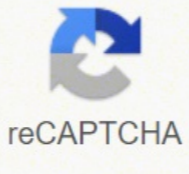

At a time when schools, kindergartens and summer camps may be in the air, you may be looking for alternative ways of childcare. What about Dependent Care FSA babysitter rental? Is that allowed? What do you need to know? Before we get into the merits, a quick tip for those whose need for childcare has increased or decreased due to COVID-19. The evolution of the cost of childcare is considered a qualifying event. This means you are allowed to change election amounts. Is it possible to hire a babysitter using the Dependent Care FSA funds? In short, yes! A Dependent Care FSA allows you to set aside tax-exempt dollars from your salary to pay for eligible child or adult care expenses. In addition to care options such as day camps and after-school, home care through a babysitter, nanny, or au pair would be eligible. All care facilities must be used "so that you (or your spouse) can work or look for a job". So no, unfortunately you cannot hire a babysitter for the evening with FSA Dependent Care funds. Who are you allowed to hire as a babysitter? You could explore a lot of options right now. Options may include professional nannies, neighbors, and even family members. Fortunately, all of these are considered eligible childcare options. This babysitting person may not be: Your spouse Your child who is under 19 years of age The parent of your qualified dependant (this only applies if the qualified dependant is your child and is under 13 years of age) A dependant claimed on your or your spouse's federal tax return. There are also some nuances based on the fact that the person you hire would be considered an employee or an Autonomous. See the revenue agency to say. What information do you need for refund and conformity purposes? In order to use the funds in your dependent Care FSA and be in accordance with the IRS, you will need information about the person you take and the assistance they have provided. For your question: to submit a question for charged assistance, we need to know know the type of service provided, the date or dates of provision of the service, the name of the employees concerned, the provider and the out-of-pocket costs for the service. Seeing our submission requests go through assistance. To file taxes: As always, you need to report contributions to your FSA Care Employee about your tax return. You will also need to provide information about the assistance itself. You need a name, an address and a social security number or an employer identification number depending on who provided the assistance.
